ACT B The aggregate amount of all Principal Receipts on the Transferred Receivables up to the end of the immediately preceding Calculation Period which have not been applied in accordance with the Trust Deed. ACT C The aggregate amount of all Transferred Collateral in cash which has not been applied in accordance with the Trust Deed.
