# Progress on share buyback programme

ING announced today that, in line with the launch of its €1,744 million share buyback programme announced on 1 October 2021, the company has repurchased 713 shares during the week of 24 January 2022 up to and including 28 January 2022.

The shares were repurchased at an average price of €12.94 for a total amount of €9,228.17. The total number of shares repurchased under this programme to date is 127,630,904 ordinary shares at an average price of €12.57 for a total consideration of €1,604,285,927.73. To date approximately 91.99% of the maximum total value of the share buyback programme has been completed.
