

## Progress on share buyback programme

ING announced today that, in line with the launch of our €1.5 billion share buyback programme announced on 11 May 2023, we repurchased 1,668,753 shares during the week of 5 June 2023 up to and including 9 June 2023.

The shares were repurchased at an average price of €12.05 for a total amount of €20,109,907.62. The total number of shares repurchased under this programme to date is 7,135,186 ordinary shares at an average price of €11.94 for a total consideration of €85,194,270.12. To date approximately 5.68% of the maximum total value of the share buyback programme has been completed.
